Introduction

Fly Hangar LLC ("Fly Hangar", "we", "us", or "our") operates the Hangar mobile application ("Hangar" or "app"). We are committed to protecting the privacy of our users ("user", "you", or "your"). This Privacy Policy outlines our practices concerning the collection, use, disclosure, and protection of your information.

Information We Collect

- **Personal Identification Information:** Includes your email address, aviation title, favorite airplane, home base airport identifier, tail number, and images you upload to create and maintain your profile.
- **Location Data:** Collected when the user specifies to display nearby airports and flights relevant to your current position.
- **Flight Data:** We collect and process ADS-B Flight Tracks linked to your tail number (only if you enter it) for flight-related features.
- **User-Generated Content:** Includes flight posts, airport reviews, forum participation, and other interactive features.

How We Use Your Information

- **To Provide and Enhance Services:** Your information helps us personalize and continually improve your experience.
- **For Communication:** To communicate with you about your account, our services, and policy changes.
- **For Analytics and App Improvement:** We use data for analytics, trends identification, and to enhance app functionality.

Data Storage and Security

- Stored in Firebase, we employ advanced security measures to protect against unauthorized access, alteration, disclosure, or destruction of your data.
- Regular audits and continuous monitoring to ensure data integrity and security.

Disclosure of Your Information

- **Legal Requirements:** We may disclose your information if required by law or in response to valid requests by authorities.
- **Service Providers:** We may share your data with third-party service providers who assist us in operating our app, conducting our business, or servicing you, so long as those parties agree to keep this information confidential.
- **Business Transfers:** In case of a merger, acquisition, or sale of all or a portion of our assets, your personal information may be transferred.

User Rights and Choices

- **Access and Control:** You can review, edit, or delete your personal data via your account settings.
- **Opt-out:** You have the option to opt-out of certain data collection and use practices.

International Data Transfer

Your information may be transferred to and maintained on computers located outside of your state or country where the data protection laws may differ from your jurisdiction.

Hangar does not knowingly collect or solicit any information from anyone under the age of 13. If we learn that we have collected personal information from a child under age 13, we will delete that information as quickly as possible.
